



- 3. The rate/s quoted shall be inclusive of packing and forwarding Charges and freight paid for destination: Pernem Govt. I.T.I, Tuem, Pernem Goa.
- 4. The make, brand, model, etc giving the details of the material quoted for should be mentioned in the quotation or else the same shall be liable for the rejection.
- 5. The material quoted for should be of ISI stand or having ISO 9001 / ISO 9002 certification, as the case may be whatever available.
- 6. The terms and conditions cited in your quotation will not be binding unless specially referred to in the enquiry /covering letter.
- 7. The instructional / operating manual shall be furnished along with any supplied material, wherever necessary as the case may be.
- 8. The quotation would be evaluated for full items / Package wise.
- 9. The quotation shall be valid for 180 days from the date of the opening of the same.
- 10. The supplied material will be inspected for acceptance & will accordingly be accepted if it is conforms to the specifications mentioned in the supply order (The material can be inspected in your presence of your representative.)
- 11. In case of rejection of the supplied material for not conforming to specification in the order, the same will be the sole responsibility of the supplier to make arrangement to collect the same at his own cost and risk immediately.
- 12. The cost of installation, key operator training / demonstration if any shall be mentioned separately along with the material in case of tools and equipment's.
- 13. The tools and equipment's supplied as the case may be should carry a warranty / guarantee against the defect for a period of 12 months from the dated of acceptance.
- 14. In case the payment is desired outside the state by a Demand Draft, the bank commission towards the same, if any, shall have to be borne by the supplier.
